CCPL has cataloged over 1,000 items to be donated to McLean County Public Library; the materials will be loaded on the bookmobile and head to McLean County on Thursday. Kiki Dreyer Burke has prepared a press release about the event and Kenton County Public Library is videotaping the send off.
- Approximately eight people have attended each of the two public meetings that have been held regarding the South Branch. JC Morgan is encouraging library supporters to attend the remaining public meetings.
